

Tarot Reading Session Payment, Pricing, Scheduling, and Refund Policy (as of 7/25/21)

Payment & Pricing

I accept PayPal and cash. I welcome and appreciate tips. I request payment in full at the time you schedule your appointment

At my discretion for in-person readings: I may accept cash prior to the session start if you are meeting me at my location. If you are not a first-time client and we have a positive history, may also accept personal checks.

I don't accept personal checks for first-time clients.

Please schedule readings at least 48-hours in advance.

Pricing - Individual Session (In Person) – \$25/30 minutes or \$50/1 hour

I require clients to show proof of COVID-19 vaccination and wear a mask throughout the session.

Pricing - Individual Session (Online/Telephone) – \$30/45 minutes

Pricing - Group Session (parties, events, groups of friends, etc.) – \$80/hour

Minimum of 2 hours required. This service is only available for outdoor, safely socially-distanced venues at this time due to COVID-19. Masks are required during the individual reading session.

Scheduling & Refunds -

For Individual Sessions (in person & online) -

If I cancel our appointment: I offer to reschedule. If a rescheduled time isn't possible, I offer the option of a credit for a reading of the same value– 30 or 60 minutes. (expires after 6 months) or to refund your payment. Credit is transferable to another for use.

If you cancel the appointment: Option to reschedule or receive a credit for a reading of the same value (expires after 6 months). No refund for cancellations. Credit is transferable to another for use.

For Group Session - Individual readings during these average about 15-20 minutes, so I tend to do 3-4 readings/hour. If there are fewer participants, the readings can be longer to balance out the time.

I require a 10-minute break after 6 readings or after about 90 minutes.

If we schedule an event of 6-8 hours, I require an additional 45-minute meal break at the halfway point during my time. Meal breaks are part of my paid, scheduled time.

Group Sessions must be scheduled at least one week in advance and paid in full at the time of scheduling the appointment. To clarify: if you want the appointment on a Saturday, you must schedule no later than the Saturday a week before.

If I cancel, I will give a full refund.

If you cancel within the first 3 days (eg. Scheduled on Saturday; counting Saturday, Sunday, & Monday - must cancel before Tuesday) of scheduling the appointment, I offer a refund of \$80 and a credit for \$80 towards a future group appointment (expires after 6 months). Any paid amount over \$160 will not be refunded or credited. Credit is transferable to another for use.

If you cancel after this time, no refund will be provided. I will credit you \$40 towards a future group appointment (expires after 6 months). Credit is transferable to another for use.

If you give less than 24 hours notice (eg. on Friday or later) of cancellation, no refund and no credit will be given.

Additionally for group sessions/events – If you have paid for time, and would like to extend it the day of:

I charge an additional \$15/hr over my standard rate of \$80/hr. For example: I'm scheduled for 3 hours – a total of \$240. If you'd like to add an additional hour, and if I'm able, it would be \$95 for that additional hour. This extra time must be paid for in full before I will "clock in" for the additional hour.

My Code of Ethics

- I require a parent/legal guardian to give permission for me to read for a minor; I do not read for anyone under age 15.
- I will not share your information, or the conversation we have during the reading, except in cases where not doing so violates the law.
- I strongly recommend one-on-one time between the client and I for the duration of the reading. This is to provide them as much privacy as possible. Of course, the client is free to discuss the reading afterward with anyone they choose, but I believe allowing this time of privacy and free expression during the reading is the most beneficial means of providing my services.
- I am not a professional/licensed therapist, doctor, prescriber, attorney, law enforcement officer, or financial advisor. The information provided in a tarot reading is not intended as a substitute for any advice provided by one of these professionals. Also known by the disclaimer: My services are for entertainment purposes only.
